





To ensure customer satisfaction in regards to noise transmission; a minimum STC of 55 is required. A STC 60 is preferable. A standard single wall construction using resilient channel produces a STC of 46. To increase this builders usually end up using more layers of gypsum board or switch to staggered and double wall system with little increases in the actual STC's. Commonly used noise control products are outdated and hard to install correctly in the field. A minimum standard one hour rated single wall assembly using the RSIC-1 will result in an STC of 56; add one more layer of board for a STC of 60. Money will be saved in labor, materials, and space. The RSIC-1 will give you a significant increase in noise control using the least amount of materials. The RSIC-1 allows you to cost effectively increase noise control, which in turn will increase tenant retention. It's a win-win situation for the owner and the tenants.



When using the RSIC-1 in floor ceiling assemblies, you no longer have to worry about the high noise levels associated with installing solid surfaces (tile or hardwoods) because of the footfall noise. This can also reduce maintenance expense associated with carpet when tenants move out and increase the perceived value of your units. If you're looking to eventually convert your developments into condominiums you will reduce the construction costs while converting the units.
